

Pastoral Secretary's Report Diocesan Synod, November 2022

Background

In 2019, the Bishop of Winchester convened a Deployment Working Group with the remit to consider the number and location of our stipendiary clergy appointments, and to make recommendations as to how finite resources could be allocated in a way which best addressed the missional priorities which the Diocesan Synod had formulated and adopted at its 2013 and 2016 conferences.

A consultation process took place over a period of several months, and the group's final recommendations were received and adopted by the Diocesan Synod at its residential conference in November 2019. Having agreed at its July 2019 meeting a 3-year financial plan, the Diocesan Synod adopted a recommendation to continue working with roughly 140 stipendiary posts, and requested that a Deployment Development Group (DDG) formulate proposals for pastoral changes which would deliver a more coherent approach to deployment. This work involved a comprehensive review of every deanery, benefice and parish in the diocese, using electoral rolls, statistics for mission, financial information, schools' information, and Experian data on population and other social demographics.

Covid arrived in early 2020, when the financial impact of the pandemic prompted a further review which was conducted by the Diocesan Resilience Team. The Diocesan Resilience Team recommended a reduction of 22 posts.

Deanery leadership teams were fully involved in both of these reviews.

Early in 2021, informal consultations began with all parishes involved – at the time, approximately 50% of parishes across the diocese were engaged in these conversations. Given the nature of the pastoral process which is made up of three consultation stages: informal, formal and public, some of the proposals evolved during this process, some were paused, but the majority began to progress through the various stages.

For context, during the period 2018-2020, seven pastoral schemes were completed. Plus, an additional four boundary change, and four re-naming pastoral orders.

Since January 2021, thirty schemes of various complexity have begun. The following is a summary of the schemes in progress and completed from January 2021 to date.

Suspension of Presentation

In 2021, seventeen suspension of presentations were put into place; and seven were specifically lifted.

In 2022, so far, eight suspension of presentations have been put into place; and three have been specifically lifted.

Suspension of presentation also falls away once a scheme comes into effect and does not need to be 'lifted' hence the higher number being put into place; many of which will end on the making of a pastoral scheme. Those that are specifically lifted are benefices where no pastoral re-organisation will be taking place and therefore the suspension is no longer required. In these instances, priests-in-charge are re-licenced as vicar/rector using the shortened vacancy procedure.

Common Tenure Interim Posts

Common Tenure Interim Posts are a way to licence clergy to a post for a limited period of time with a specific purpose agreed for that period, for instance after a particularly long incumbency where an adjustment to change needs to be managed, or where pastoral breakdown may have occurred, or simply to test sustainability of the parish, etc.

Three Common Tenure Interim Posts have been agreed to date in 2022. They include: Sherbornes with Pamber; Winchester Holy Trinity; Southampton St Denys. Suspension of presentation is required when a CTIP is proposed.

Removing the legal effects of consecration

Removing the legal effects of consecration and transferring part of the churchyard to the PCC for their parochial purposes often occurs when the PCC wish to use that land for their hall, or other rental purposes as this becomes easier to manage once the land sits outside the faculty jurisdiction.

Church closures and re-use

Church closures are both rare and extremely lengthy processes. Closure is usually sought by the parish, not by the diocese. The DMPC has a policy in place which seeks to find alternative use for the building at the same time as closure.

Dissolution of Group Ministries

Group ministries were 'in fashion' several years ago and were a way to formalise joint working across benefice boundaries, perhaps prior to a possible union, or simply to encourage collegiate working. Unfortunately, we have found that these groups tend to fall into disuse with the passing of time with the result that the legal structure still exists without the actual relationship on the ground. Therefore, where we find they have been forgotten, we prefer to dismantle the legal structure in favour of more organic joint working.
