PTO - Permission to Officiate, a licence given to clergy by the diocesan bishop after DBS checks and safeguarding training. PTO clergy are often retired but not always. * Non PTO Clergy - including rectors, vicars, team rectors, team vicars, priests-in-charge, associate/assistant priest/minister/vicar/rector, curate, assistant curate. * PTO Clergy - those who have applied to and been granted Permission to Officiate by the diocesan bishop, a 3 year licence which must be renewed.
