

WE PHILIP by Divine Permission Bishop of Winchester

by virtue of the provisions of Section 13 of the Dioceses, Pastoral and Mission Measure 2007 and with effect from the day after this instrument is made

NOW HEREBY DELEGATE to the Right Reverend **KELLY ANNE BETTERIDGE** Bishop of Basingstoke such of our episcopal functions as are hereinafter set out

1. The following functions may be exercised at all times until this instrument shall cease to have effect as hereinafter provided
 - (a) At such times and in such places within our Diocese as we shall appoint in our name and on our behalf to ordain to the Holy Orders of Deacons and Priests according to the rites of the Church of England such persons as shall be presented to her for that purpose under our direction
 - (b) In our name and on our behalf at such times and in such places within our Diocese as we shall appoint to license to their respective curacies team vicarages or chaplaincies such persons as shall be nominated thereto
 - (c) In our name to collate or institute to their respective vacant benefices such priests as we shall nominate or shall be duly presented thereto
 - (d) In our name to admit and to licence to their respective parishes or benefices duly qualified Readers, evangelists and other authorised lay ministers and lay workers
 - (e) To consecrate dedicate and license for Divine Worship or for Marriage according to the rites and ceremonies of the Church of England any Churches or Chapels within our Diocese previously approved by us and any Churchyards Chapelyards Cemeteries or additions to Burial Grounds for any Parish within our Diocese

- (f) To administer the rite of Confirmation within our Diocese
- (g) In relation only to those specific matters concerning such named clerks in holy orders as we may specify in writing, to exercise our disciplinary functions under the Clergy Discipline Measure 2003 as Bishop of the Diocese of Winchester
- (h) To exercise our functions under any Canon or enactment made under section 9(2) of the Clergy (Ordination and Miscellaneous Provisions) Measure (applications for a faculty to admit into Holy Orders certain remarried persons)
- (i) For the purposes aforesaid to be our Commissary and in addition to perform all other functions peculiar and appropriate to the Order of Bishops within our Diocese

2. The following functions may be performed by the said Bishop of Basingstoke at any time when we shall be absent from our Diocese (having notified the said Bishop in writing of our intended absence and that the provisions of this clause are to come into effect during such period)

or at any time when we shall be otherwise incapable of performing the following functions ourselves

or during the period from the commencement of a vacancy in our See until this Instrument shall cease to have effect

Namely:-

- (a) to perform all our Episcopal functions within and relating to the area of the Archdeaconry of Winchester and any parishes benefices and deaneries therein including the property of any such benefice

Further, and only in the absence or incapacity of another person in episcopal orders in the diocese who is for the time being authorised to discharge the relevant functions of the Bishop, or by agreement with said other person in episcopal orders, or in case of necessity

- (b) to perform all our Episcopal function elsewhere in the Diocese of Winchester including the property of any other benefice
- (c) to exercise our disciplinary functions under the Clergy Discipline Measure 2003 as Bishop of the Diocese of Winchester
- (d) (so far as we can or may) to perform all our Episcopal functions relating to the Diocese or See of Winchester as a whole

and all of our Episcopal functions relation to the Cathedral Church of Winchester and the Cathedral Close whether under Statutes of the said Cathedral or otherwise

and all our Episcopal functions in relation to any other body or institution of which we are Visitor or in respect of which we exercise Episcopal Functions

3. This instrument shall be subject to the provisions of Sections 13 to 16 inclusive of the Dioceses, Pastoral and Mission Measure 2007 and remain in effect until determined by virtue of the provisions of subsections (7) (9) or (10) of Section 13 of the said Measure
